Methods and materials for containment and cleaning up : Eliminate all ignition sources if safe to do so. Stop leak if safe to do so. For large spills, dike spilled material or otherwise contain material to ensure runoff does not reach a waterway.

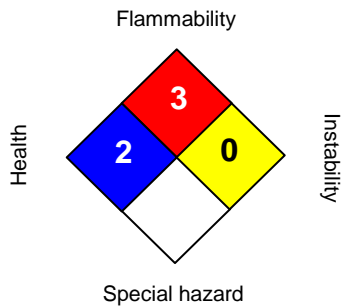
